

*Heritage Regulations 2017*

**Fee Schedule – 2018-19**

The value of a fee unit for the financial year commencing 1 July 2018 is \$14.45, as set by the *Monetary Units Act 2004*.

The Heritage Regulations 2017 provide for fees to be waived in certain circumstances.
