At a meeting of the Heritage Council of Victoria on 3 October 2019 it was determined that, in accordance with section 62 of the *Heritage Act 2017*, the above place is to be amended in the Heritage Register, by making the following amendments:

- amending the extent of registration by adding land, in accordance with the Executive Director's recommendation report, and in accordance with Attachment 1; and
- amending the categories of works or activities which may be carried out in relation to the place for which a permit under the *Heritage Act 2017* is not required, in accordance with the relevant terms of the Executive Director's recommendation report.

This decision was reached having considered the information included in the Executive Director's recommendation report and submissions received pursuant to s.44 of the Heritage Act 2017. Subject: Change to written extent of registration

Dear Rhonda

We have become aware that the written extent of registration for the Queen Victoria Market does not clearly reflect Diagram 734 (on page 4 of the ED Recommendation). The ED proposes that the wording is revised to more clearly reflect the inclusion of verandahs and awnings on Victoria, Elizabeth, Therry, Queen, Franklin and Peel Streets. This extent aligns with the National Heritage List boundary, included on pg 3 of the ED Recommendation.

City of Melbourne has advised that they are comfortable with this change in wording.

The proposed revised wording is as follows (changes highlighted in green).

Current written extent

All of the place shown hatched on Diagram 734 encompassing all of Crown Allotments 4, 5, 6, and 7, Section F Parish of Melbourne North, Township of Melbourne at West Melbourne and part of the road reserve of Queen Street.

Revised written extent

All of the place shown hatched on Diagram 734 encompassing all of Crown Allotments 4, 5, 6, and 7, Section F Parish of Melbourne North, Township of Melbourne at West Melbourne, part of the road reserve of Queen Street and the land forming the footprint of the permanent verandahs and awnings on Victoria, Elizabeth, Therry, Queen, Franklin and Peel Streets.
